DELAY IN COMPLETION OF THE SHARE PURCHASE AGREEMENT

Reference is made to the announcements dated 6 May 2009 and 28 August 2009 (the “Joint Announcements”) jointly issued by Teamsun Technology (HK) Limited (the “Offeror”) and Automated Systems Holdings Limited (the “Company”), the circular dated 30 June 2009 (the “Circular”) and the announcement dated 17 July 2009 (the “Announcement”) both issued by the Company.
